ORDINANCE NO.: 2009-1

*An ordinance of the Borough of Lilly
Amending Ordinance 1-1981
Identifying and Establishing Stop
Signs and Parking Restrictions
on Borough Streets*

WHEREAS Borough Ordinance 1-1981 established certain intersections in the Borough as stop intersections.

WHEREAS Borough Ordinance 1-1981 established parking restrictions along certain streets and areas within the Borough.

WHEREAS the Borough Council has determined that Borough Ordinance 1-1981 requires amending to recognize additional stop and parking restrictions within the Borough.

NOW THEREFORE, the Borough of Lilly Council hereby and herein **ORDAINS AND ENACTS** as follows:

Section 1:

Article I, Section 14 of Ordinance 1-1981 is hereby and herein amended to include the following intersections:

- 1) *Railroad Street and North Grant Street*
- 2) *South Railroad Street and Cleveland Street*
- 3) *Hawthorne Street and Cemetery Street*

Section 2:

Article II, Section 2 of Ordinance 1-1981 is hereby and herein amended to read as follows:

Section 2. Winter Parking: From November 1 through March 31

between the hours of midnight to 6:00 a.m. the following streets are designated as no-parking streets for the purpose of snow removal:

Borough employees are herein authorized to issue parking tickets to any vehicle parked in violation of this Section.

Section 3:

Article II, Section 5(a) of Ordinance 1-1981 is hereby and herein amended to include the following alley:

- 2) *Chestnut Alley between the ambulance building and the street corner.*

Section 4:

Article II, Section 6 of Ordinance 1-1981 is hereby and herein amended to include the following locations at the times designated herein:

- 3) *Cleveland Street in front of the Lilly Borough Municipal Offices (3 spaces) One hour limit between 8:00 a.m. and 5:00 p.m.*
- 4) *Corner of Cleveland Street
Fifteen (15) minute time limit at all times*
- 5) *Route 53 (3 spaces)
One hour limit between 8:00 a.m. and 5:00 p.m.*

Section 5:

Article III, Section 5(c) of Ordinance 1-1981 is hereby and herein amended to include the following street or portions thereof:

- 1) *West on Piper Street from 240 Piper Street to the intersection Piper Street and Route 53.*

Section 6:

All remaining provisions of Ordinance 1-1981, not in conflict herewith shall remain in full force and effect.
